**Application Guidelines**

1. Introduction

Graduate School of Modern Society and Culture is a comprehensive graduate school where students make research in the fields of Literature, Law, Economy and Business, aiming to obtain Master Degrees and Doctor Degrees.

Among ten courses provided by the graduate school, the Course of International Society under the Major of Legal Society awards Master Degrees of Law(LL.M ), Public Administration, or Philosophy by making researches into themes related to laws and public administration in English with all the necessary process conducted in English, from entrance exams, lectures and seminars, to thesis writing.

This guideline is for students who plan to take an entrance examination to the Course of International Society which is to be held in February 2023 for admission in April 2023 and October 2023.

2. Admission Policy

This course aims to foster professionals and researchers with ability to find problems, related to laws and public administration, to be resolved in a current society and to propose solutions to them with professional expertise and insights, with the view of building a mutually acceptable society.

Students are most welcome who understand our admission policy and have enthusiasm and potential ability to be such professionals and researchers.

#### 5. Application period

**[Applications sent by postal mail must arrive during these specified dates.]**

Submission by postal mail: Please make sure to send the application by express registered mail.

- Your application may be rejected if you do not have qualifications to apply, and these documents would be sent back. At this occasion, your testing fee also would be paid back.

#### 7. Application procedures and documents

Applicants are requested to submit the following documents and items in person or by mail within the application period. Please fill out the application documents in English or in Japanese, as follows:

- (1) Application for admission (CV), examination admission card, and photo card
- (2) Statement of the reason for application
- (3) Research plan
- (4) Research progress report
- (5) Graduation certificate, graduation expectation certificate, or academic degree certification issued by the applicant's graduating university
  - An original academic degree certification will be returned after copying.
- (6) Academic transcript issued by the applicant's graduating university
- (7) Passport copy and family register copy of the applicant's native country or proof of

citizenship (foreign national applicants only)

- (8) Copy of the Residence Card or copy of entry visa Foreign national applicants in Japan are requested to submit front- and back-page copies of their “Residence card” issued by a municipality certifying their status of residence and period of stay. Moreover, foreign national applicants who plan to stay in Japan for a short period to take an entrance exam are requested to submit a copy of their entry visa.
- (9) Three photos 4 cm (about 1.6 in) long and 3 cm (about 1.2 in) wide of the frontal upper body (without hat or cap), taken within 3 months before the application. Students should write down nationality and name on the back sides of the photos.
- (10) English proficiency certificate (applicants having a certificate such as TOEFL are requested to submit it).
- (11) Envelope to return the examination admission card. (Please attach 94 yen or its equivalent in postage. For a person applying from abroad, please enclose an international reply coupon required to send a document weighing 50 g [1.75 oz].)
- (12) Certificate proving payment of the testing fee

Please write down the required information in the “transfer payment request, transfer payment and commission receipt, and certificate proving payment of a testing fee.” Then please make a transfer payment of the testing fee (30,000 yen) at a financial institution (except the Japan Post Bank), and submit the “certificate proving payment of the testing fee (for submission to Niigata University),” which has been returned to the applicant from the financial institution. Please make sure to confirm that the financial institution’s receipt stamp is imprinted. The applicants are also required to pay the transfer fee.

- (a) Please write down the applicant’s name in the client name section.
- (b) Please make the transfer payment within the following period. Payment transfer cannot be made on Saturday, Sunday and national holiday.

**From December 2, 2022 (Friday) to December 22, 2022 (Thursday), by 15:00(Japan time)**

- (c) Payment cannot be made through an ATM (Automated Teller Machine).
- (d) Japanese Government (MONBUKAGAKUSHO) Scholarship students need not pay the testing fee.
- (e) The testing fee will not be returned after payment has been made.

However, if an applicant does not submit his or her application documents within the application period after the testing fee is paid, the fee (30,000 yen) will be returned; please refer to the contact in section 11 below.

## 8. Enrollee selection methods

Selection is conducted through written exam (see Table 1 at P.7 for subjects) and oral exams.

\*Examinees who commit following illegal acts are to lose the qualification of taking the exam and to leave the exam room immediately,

1. False information written deliberately in the application form;
2. Cheating at the exam;

3. Use of electronic devices such as a mobile phone during the exam.

#### 12. Announcement of successful applicants

##### (1) Date

#### 13. Admission procedure

The admission procedure period is shown below.

**April 2023 Admission From March 7, 2023 (Tuesday) to March 10, 2023 (Friday)**

**October 2023 Admission From September 6, 2023 (Wednesday) to September 8, 2023 (Friday)**

The admission fee is shown below, and other details regarding the admission procedure will

be mailed to the successful applicants.

- Admission fee: 282,000 yen (estimated amount)

The successful applicants are required to pay the following tuition fee at the beginning of each semester.

- Tuition fee: 535,800 yen per a year, 267,900 yen per each semester (estimated amount)

(If the tuition fee amount is modified while the student is attending the university, a new tuition fee will be applied from the modification date.)

#### 14. Treatment of personal information used to select the enrollees

- (1) Regarding the names, addresses, and other personal information that the applicants gave to the university when they applied, it will be used only for the following purposes: (a) the enrollee selection (application process, selection process), (b) announcement of successful applicants, (c) the admission procedure, (d) research, study, and analysis of the enrollee selection methods or similar, and (e) other tasks associated with these matters.
- (2) The personal information regarding the exam results used to select the enrollees will be used to research, study, and analyze the enrollee selection methods or similar.
- (3) Regarding only an enrollee's exam results and personal information given to the university upon application, it will be used after the admission to conduct tasks related to the following: (a) educational affairs (school register, study instructions, etc.), (b) matters related to student support (health management, scholarship application, etc.), and (c) tuition fees, etc.
- (4) Moreover, in regard to personal information, the successful applicant's name and address may be used by the university's alumni and support associations.

#### 15. System for extending the period of study

This system is for students who meet any of the following criteria: (i) applicants currently in employment (including a part-time job) who have difficulty in securing necessary time for your study, (ii) applicants currently in childbirth, childcare or nursing care of a relative who have difficulty in securing necessary time for your study, (iii) applicants with a physical or mental disability. The course term can be extended up to 3 or 4 years beyond the standard term of 2 years. Tuition fees in this system must be paid in installments by dividing the total tuition fee amount for the standard period of your curriculum by the approved number of years of study.

#### 16. Exemption from Entrance Examination Fee

To help alleviate the economic burden on disaster victims, and to secure the educational opportunities of applicants from the affected areas, Niigata University will be implementing a special measure for exemption from entrance examination fee. For details, please check the university website.
